6. SECURITY DEPOSIT USE & REFUND

The security deposit may be applied toward:

Vehicle damage

Excess mileage

Late return fees

Cleaning fees

Traffic tickets, tolls, or violations

Unused deposit amounts will be refunded within 3–5 business days after vehicle inspection.

7. LATE RETURN POLICY

\$25 per hour late fee

Vehicle not returned within 24 hours of scheduled return time may be reported stolen

8. PROHIBITED USE

Vehicle may NOT be used for:

Illegal activity

Rideshare or delivery services

Towing

Off-road driving

Smoking or vaping inside the vehicle

Use by unauthorized drivers

Violations may result in immediate termination without refund.

12. GPS TRACKING & SECURITY DISCLOSURE

Renter acknowledges and consents that the vehicle may be equipped with GPS tracking and/or remote disable technology for security and recovery purposes.

13. INSURANCE

Renter understands they are financially responsible for damages not covered by insurance. Proof of insurance may be required prior to vehicle release.
